


Comparative Analysis of Trust Jurisdictions

Where Does Your Trust Stand?



Top Trust jurisdictions like DE, NV, and SD have accommodating legislation that permits silent trusts, allows for divided responsibilities as the grantor sees fit, and has strong asset protection. Bottom-tier jurisdictions make drafting more challenging, and courts will also not honor asset asset-protecting spendthrift clauses for certain creditors.

The chart below reveals how well each State allows a trust to be created according to the trustor's wishes and how well their intent is respected throughout the trust's duration and unpredictability. The chart helps identify those factors.
